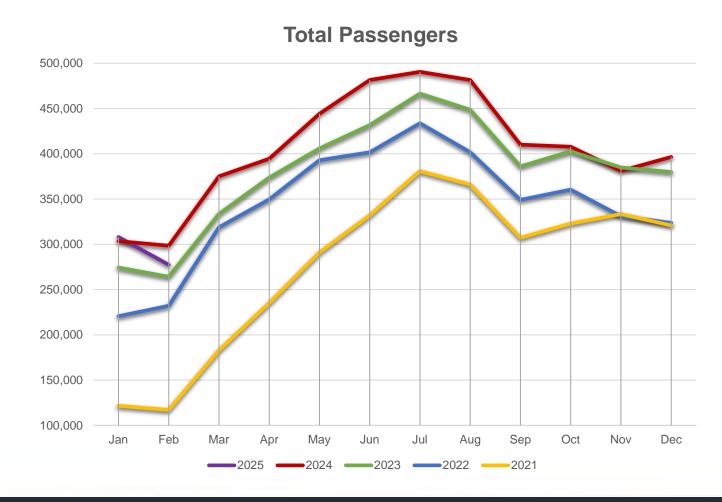

Runway 5/23 Rehabilitation

- Completed in two phases:
 - R/W 23 end completed Nov. 2, 2023
 - R/W 5 end completed Oct. 31, 2024
- Environmentally sustainable project:
 - Rubblizing both ends of the runway eliminated 33,333 CY of concrete waste
 - Saved 460 Tons of CO2 emissions
 - Saved 263,200 total miles of truck traffic
 - Saved 52,640 gallons of fuel

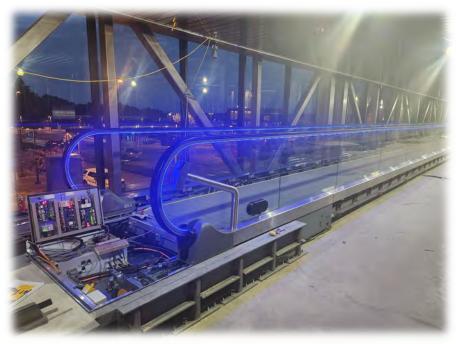

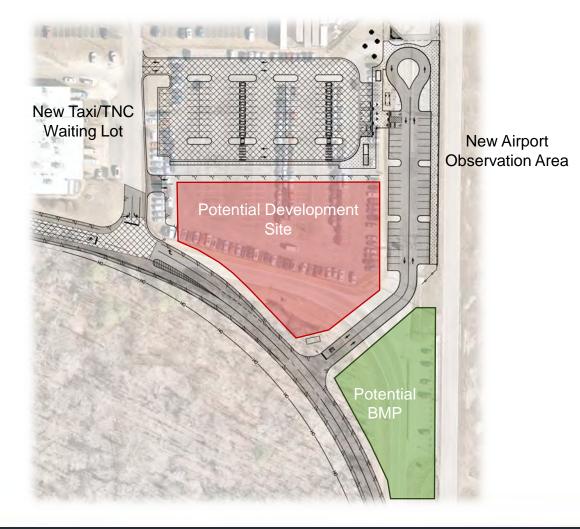
- Larger overall structure from 268,128 sf to 310,560 sf
- More lanes for QTA Service Facility
 - 6 wash bays increased to 8
 - 6 fueling / cleaning positions increased to 10
- Increased onsite capacity
 - Was 768 total spaces (+125 over existing)
 - Now 1,008 total spaces (+365 over existing)
- Enabling Project
 - TNC / Taxi Relocation
 - Softening of Robin Hood Road curve due to increased activity in area

Current Program Cost Estimate

- July 2024 Estimate \$203M with \$10.25 CFC
- Added or Subsequent Additions:
 - TNC / Taxi Relocation \$4M
 - Robin Hood Road Realignment \$5M
 - Access road around ConRAC \$5M
 - Additional structural bay for ConRAC \$15M
 - NAA estimate increased to \$232M with additional items above
- However, program anticipated to be \$175M with CFC of \$9/day
 - Updated program costs based on estimates received during CMR process



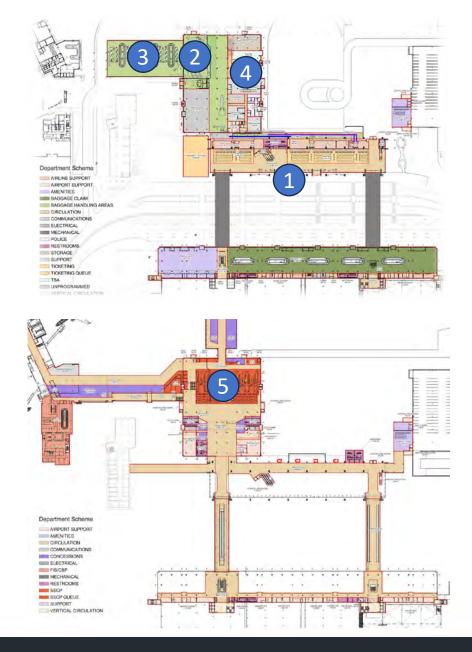

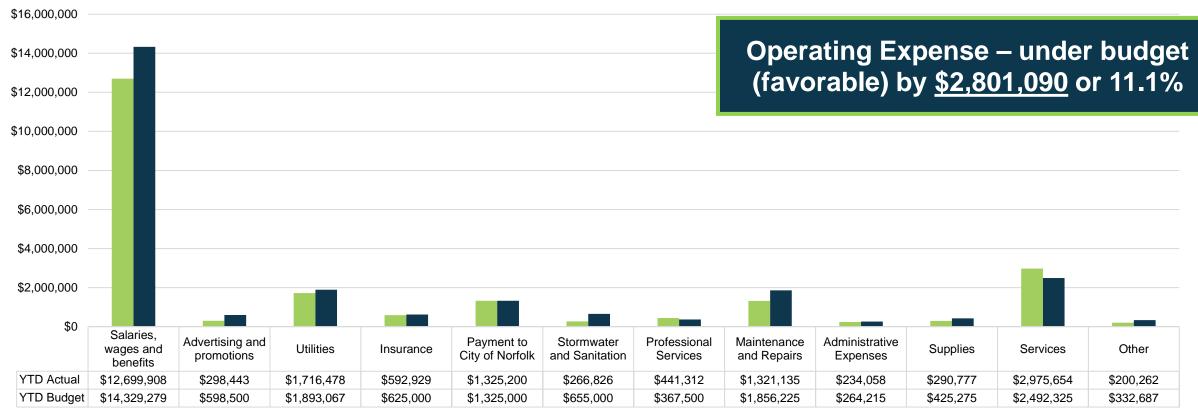

Year to Date Budgeted vs Year to Date Actual

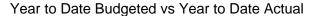


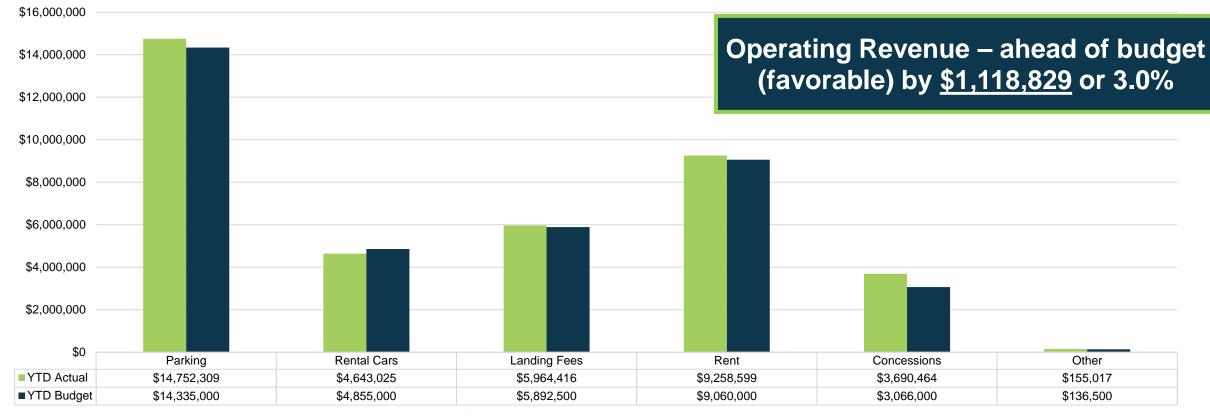

December 2024 Operating Revenues





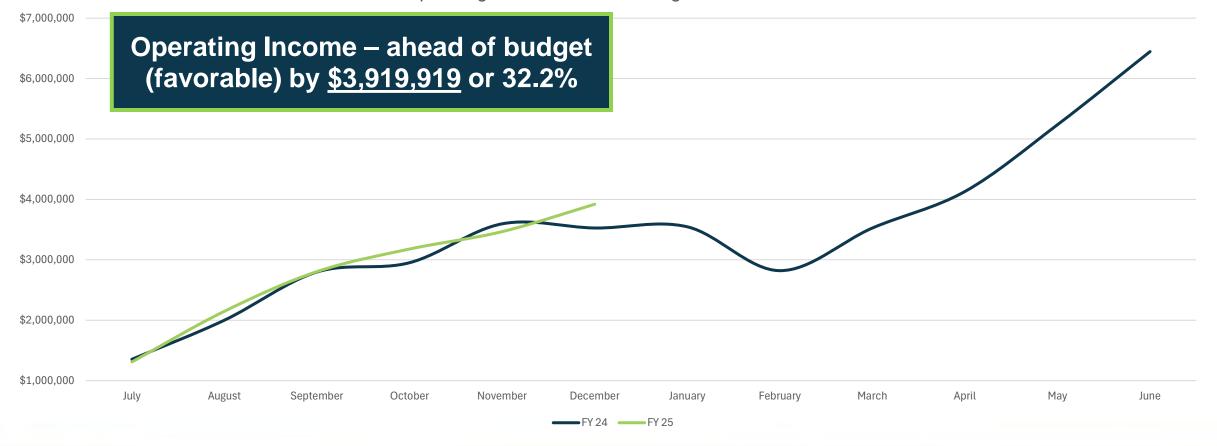






Year to Date Operating Income

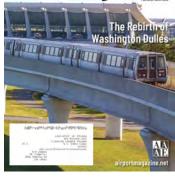

- ORF retains it's 4-Star Skytrax rating for the 3rd year in a row
 - "Norfolk International Airport is continuing to deliver a 4-Star Airport experience across various frontline product and service categories, demonstrating ongoing progress. Customer satisfaction levels in most touchpoints are generally above the 4-Star Rating level, with the primary limitations to a 5-Star rating being the bifurcated airside concourses, seating standards, and WiFi provision. We note that these areas are being addressed, alongside associated airside facility enhancements, and when completed Norfolk International Airport is well-positioned to achieve the highest 5-Star Airport Rating."

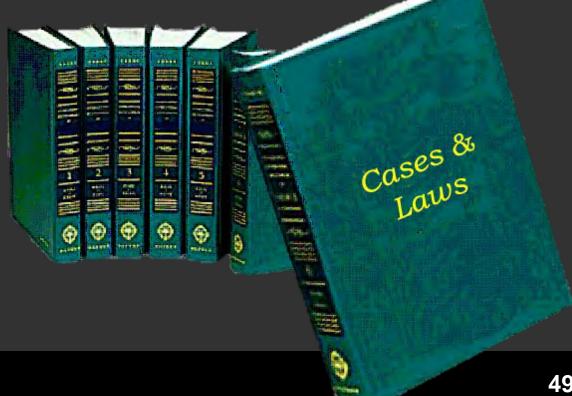

Why the emphasis on federal requirements?

- Federal laws and regulations comprehensively regulate
 - Airport operations
 - Airport finances
 - Aircraft operations
- The federal government
 - Provides substantial grant funds every year
 - Approves use of Passenger Facility Charges (PFCs)
 - Licenses airports to receive airline service









How is the airport regulated?

- Airports are primarily regulated two ways:
 - Formal regulations promulgated by FAA, TSA, and others
 - Focus on aeronautical operations, safety, and security
 - Less important for today's discussion
 - Grant assurances that attach to receipt of federal funds
 - Recipients know as "sponsor"
 - Financial, land use, and many other topics
 - Agency guidance and policy

What are Grant Assurances?

- Regulation by contract: airport sponsor agrees to subject itself to FAA regulation in exchange for FAA grants
- Contractual conditions imposed through acceptance of federal grant funds
- Enforced through informal and formal administrative processes
- Consequences for non-compliance can be significant



Contractual terms with regulatory effect

- 39 contract terms (+1 pending)
- Many not all required by statute

Functionally, but not formally, regulatory

Most bind for 20 years; 3 are perpetual





Enforcement

- This is how FAA regulates airports
- FAA aggressively enforces Grant Assurances
- FAA has separate administrative adjudication process
- Penalties for violations can be severe

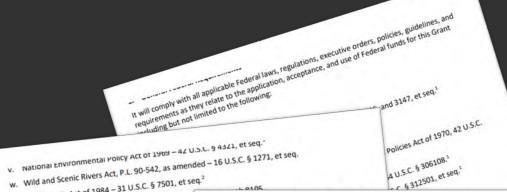

Assurance 19 – Operations and maintenance

The airport ... shall be operated at all times in a **safe and serviceable condition** and in accordance with [requirements] . . prescribed by applicable Federal, state, and local agencies for maintenance and operation.

[The sponsor] will not cause or permit any activity or action thereon which would interfere with its use for airport purposes.

Assurance 19 – Safe and functioning airport

- Keeping airport safe and open for aircraft
- FAA approval for nonaeronautical closure
- Contingency planning

- ✓ Maintain, inspect, and repair facilities regularly
 - ✓ Keep airport open for public use
 - ✓ Mark hazards and warn pilots of airport conditions

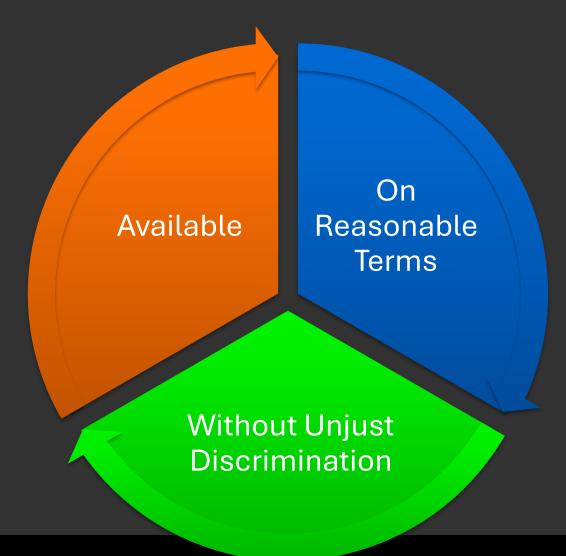


Assurance 22 – Economic nondiscrimination

[The sponsor] will make the airport **available** for public use on **reasonable terms** and **without unjust discrimination** to all types, kinds and classes of aeronautical activities . . .



Assurance 22 – key components





March 27, 2025 63

Assurance 22 – reasonable and not unjustly discriminatory terms

- Terms must be:
 - Attainable
 - Rational
 - Uniformly applied
- Treat similarly situated aeronautical operators similarly
 - Facilities
 - Investment/risk
 - Signatory status
 - Time



Assurance 23 – Exclusive rights

[The sponsor] will permit no exclusive right for the use of the airport by any person providing, or intending to provide, aeronautical services to the public. ...



Assurance 23 – Meaning of "exclusive"

- Prohibits excluding a prospective aeronautical user
- Prohibits granting rights to one-and-only aeronautical user
- Can be express or implied

Sources of federal regulation

Permissible uses of revenue

Complicated to use for incentives, off-airport mitigation highly regulated



Can never use for general economic development

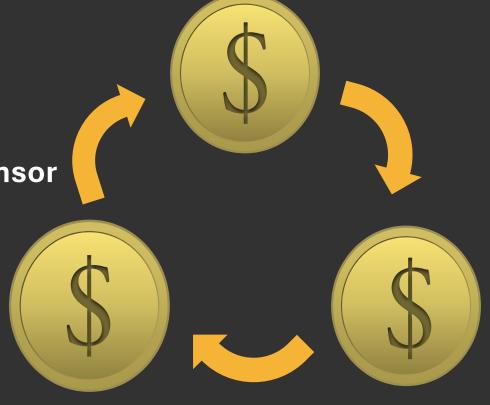
OK to use for capital and operating costs of airport

Closed fiscal system

- Airport revenue can only be used for airport expenses
- No off-airport diversion
- Airport revenue may be used for ---
 - Airport
 - Airport system
 - Facilities owned and operated by airport sponsor and directly and substantially related to air transportation

Revenue diversion



Unlawful revenue diversion

- Unlawful revenue diversion is the use of airport revenue for purposes other than the capital or operating costs of an airport
- Violation of federal law;
 subject to severe penalties





March 27, 2025

Examples –revenue diversion

- Free or discounted rent to the local public works department to store trucks; any free rent for local government facilities
- Payment to local fire department in excess of the value of fire protection services provided to the airport
- More-than-modest charitable contributions or sponsorships
- Payments to airlines to encourage more airline service

Payments to local governments

- Risky and must be carefully designed
- Narrow exception to prohibition on revenue diversion
- Must be entirely voluntary airports like
 ORF are usually tax exempt
- OK to make reasonable payments for services based upon the value of those services, OR



Payments in lieu of taxes

- OK make "payment in lieu of taxes" (PILOT) but only if
 - "based on a reasonable, transparent cost allocation formula calculated consistently for other comparable units or cost centers of government" and
 - Payments do not exceed stated tax rates
- Cannot both pay for services and make a PILOT

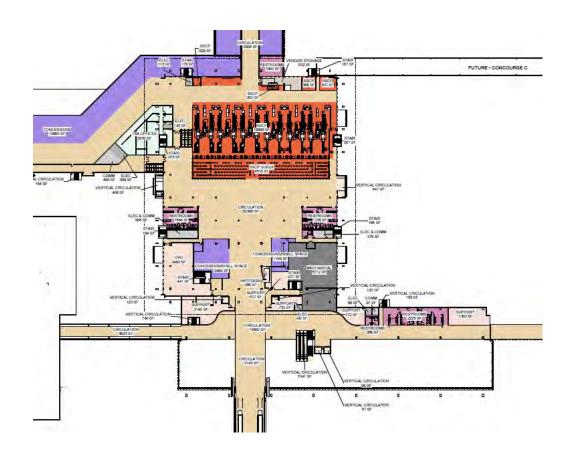


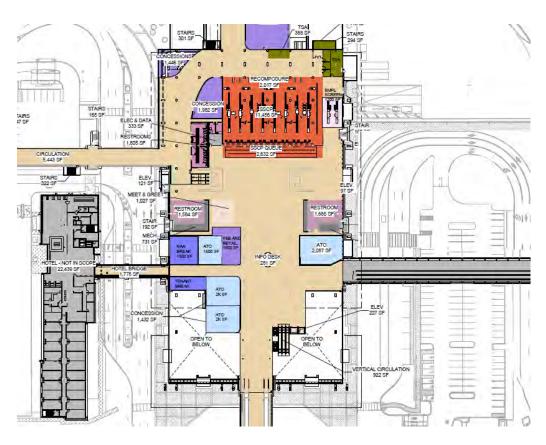

Complexity Statement

- Gresham Smith provided a detailed Project Complexity Analysis to the Authority in a letter dated March 25, 2025
 - Gresham considered many elements of the project in their analysis which include but are not limited to: Difficult site location, unique equipment and specialized building systems, multifaceted nature of the project and the required intricate phasing to accommodate the airport's 24/7 operational environment
- Staff concurs with Gresham's conclusion that the Terminal Development Project is a complex project and that, based on the complex nature of this project, the use of competitive sealed bidding is an operational and financial disadvantage to the Authority
- Therefore, Staff recommends use of Construction Manager-at-Risk procurement to deliver the Terminal Development Project and all required enabling efforts
- Note Staff will request funds for construction as part of the FY27 Budget process
 - FY26 Funds will cover CMR Preconstruction Phase Services and completion of Construction Documents





Recommended Resolution

- The Facilities Development Committee recommends the following:
 - Due to the complex nature of the Terminal Development Program Phase 1 construction environment and immediate need for improvements in the concessions, ticket lobby, checkpoint and baggage make-up operations at Norfolk International Airport, the Facilities Development Committee hereby recommends that the Board accept Staff's recommendation to utilize the Construction Manager-at-Risk project delivery method for the Terminal Development Project Phase 1.
